



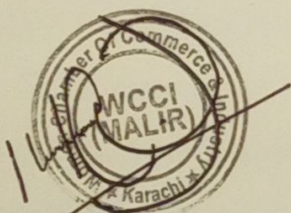

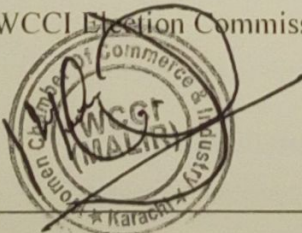

4.	The members who have any objection on the provisional voters list filed objection in writing to the Secretary General within seven days of the issuance of the voters' list.	25 th July
5.	The Secretary General shall decide the objections within five days from receipt of objections.	30 th July
6.	Any member aggrieved the decision of Secretary General may file appeal before the Election Commission within three days.	3 rd August

12.	Candidate list within twenty-four hours of receipt of nomination papers, a copy of the final list of voters shall be provided to each contesting.	18 th August
